Would you like to become a dealer / retailer for us?

If you are interested in registering as a dealer for the motogadget GmbH, we require documented proof that you are indeed a professional. Unfortunately a business registration confirmation only is not enough, since everyone can acquire one of those at most government agencies without much effort. They do not proof that you actually have a running business.

As you will understand, we offer the retail prices for resale purposes only. In the interest of everyone involved, customer- and technical support for our high quality products have to be at a good level. We think that capable businesses and certified specialists are suited best to meet these requirements.

Therefore we ask applicants for proof of their active business. The best way would be to provide us your commercial website (with valid company information). This allows us to get a accurate picture of your business, and its field of activities.

Should you not have a website, we require at least a document with official letterhead (e.g. from an invoice template) or a brochure, advertising or something equivalent that shows your activities of a retailer.

Of course we additionally require standard business verifications, like your business registration and tax-ID.

Please fill out the enclosed questionnaire as fully as possible, and send it back to us via eMail or Fax. We will check it and decide about.

Dealer / retailer conditions and ordering process

Pricelist:

After successful registration, and being accepted as a dealer / retailer, the current dealer pricelist will be made available to you. The dealer margin is depending on the specific products. The price scale depends on the turnover in the last 12 months, in which the turnover is accumulated. Should the dealer / retailer reach the scale in a shorter period, the new prices will become valid immediately. Should the sales of the last 12 months drop below the required volume, the customer will be set back to the according pricelist.

Payment:

Dealers / Retailers in other countries than Germany can only pay by prepayment via bank transfer or PayPal. The PayPal fee (currently 3,9% on the sum total) will be added to the price.

Special conditions can be arranged only with personal approval of the management.

We do not bear any bank fees. The customer is responsible for his bank account having sufficient funds to cover the transfer of the full costs to our account.

First time order:

After we have accepted you as a dealer / retailer, and have made the dealer pricelist available to you, you can make your first order via email or fax.

For your orders please use the article numbers on the pricelist, and state how you intend to pay (see ‚Payment‘).

Only after receipt of an order your data will be entered into our ERP system, and your customer ID will be generated.

Order via web shop / dealer login:

After you have been entered into our ERP system, your data will be transferred to our web shop within 1-2 days. After that you can use the email address you provided for the webshop (user) and your password (small ‚m‘ before your customer ID – e.g. ‚m12345‘) to log in and order directly.

You will immediately receive an order confirmation with the full costs, so you are able to make the payment.

IMPORTANT: If you would like to change your data in our webshop (address, company name etc.), please let our sales department know. You cannot change the data yourself. The new data is valid only after our sales department has changed it.
